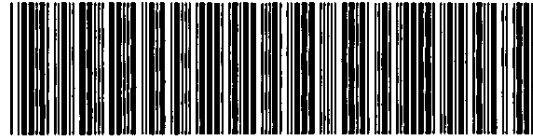

This limited partnership is being dissolved due to the liquidation of all assets and cessation of all business activities.


