RECITALS

A. The CERTIFICATE OF LIMITED PARTNERSHIP of the Partnership, executed on January 25, 1989, (the "Certificate") was filed with the Florida Department of State on February 6, 1989, and has not been amended since the date of filing.

B. It has been determined that, because of a typographical error, Section 5 of the Certificate erroneously states that the termination date of the Partnership is December

C. At all times since the date of its execution on February 2, 1989, the PARTNERSHIP AGREEMENT OF LIMITED OF PARTNERSHIP has correctly stated that the termination date of the Partnership is December 31, 2018.

D. The general partner of the Partnership desires to file this Correction to correct such typographical error in the Certificate.

CORRECTION


1. Correction of Termination Year: Reference to the year "2008" in section 5 of the Certificate is hereby deleted in its entirety and replaced to read as follows: "2018".

2. Retroactive Effective Date: Pursuant to Section 620.1207(3) of the Florida Statutes, this Correction is effective retroactively as of the original effective date of the Certificate, except as otherwise required by Section 620.1207(3)(a)-(b) of the Florida Statutes.
