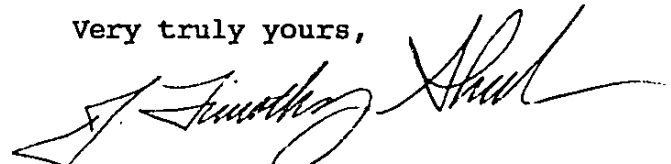

AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF

III. AGENT FOR SERVICE OF PROCESS:

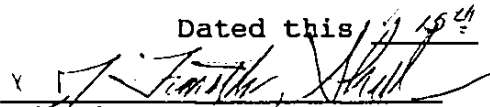
