Pursuant to the provisions of Section 620.109, Florida Statutes, CNL Income Fund VII, Ltd., a Florida limited partnership (the "Partnership"), whose Certificate of Limited Partnership (the "Certificate") was filed with the Florida Department of State on August 18, 1989, adopts the following Certificate of Amendment to its Certificate of Limited Partnership.


