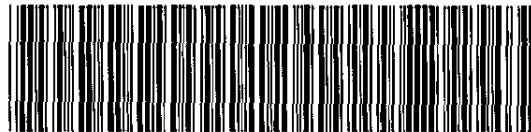

We have received your document for THE LINCER FAMILY LIMITED PARTNERSHIP, however, upon receipt of your document no check was enclosed. Please send a check or money order payable to the Department of State for \$52.50.

The subject limited partnership's certificate of authority was revoked April 2, 1993, for failure to file an annual report/uniform business report.

To reinstate the limited partnership you should file a current annual report/uniform business report/reinstatement, which has been signed by a general partner.

The partnership must pay filing fees totaling \$1,821.00, an amount equal to the total amount it would have paid this office had it filed its annual reports/uniform business reports in a timely manner. In addition to the filing fees, there is a fine of \$500 for each year or part thereof during which the limited partnership's certificate was revoked for the years 1984 through the present, and \$88.75 supplemental fee per year from 1992 forward. If a registered agent has not been previously designated, an additional \$35 is due to designate the registered agent.

The total amount due to reinstate is \$8,321.00. An additional \$8.75 is due for each certificate of status requested.


