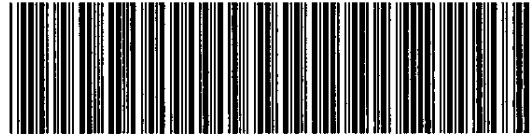



Consent to the Appointment of a Person to Wind up Morrison Family Limited Partnership's
Activities

Bryan W. Paul, as Trustee of the Betty J. Morrison Irrevocable Children's Trust (the "Trustee"), gives the following consent pursuant to Section 620.1803(3), Florida Statutes (2016), and states:

1. Morrison Family Limited Partnership is a dissolved Florida limited partnership.
2. The dissolved limited partnership's initial certificate of limited partnership was filed with the Florida Department of State on October 26, 1989, Document Number A29121.
3. The dissolved limited partnership does not have a general partner.
4. The Trustee became the sole limited partner of the dissolved limited partnership upon the death of Betty J. Morrison on December 3, 2013. The Trustee remains the sole limited partner and owns all of the rights to receive distributions as a limited partner.

Amendment to Certificate of Limited Partnership

The Certificate of Limited Partnership for the dissolved Florida limited partnership known as Morrison Family Limited Partnership is amended as stated below:
