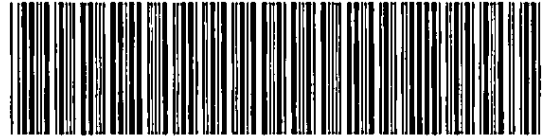

**Statement of Termination for
Morrison Family Limited Partnership**


Pursuant to the provisions of section 620.1203, Florida Statutes, Morrison Family Limited Partnership, a dissolved Florida limited partnership (the "Dissolved Limited Partnership"), whose certificate was filed with the Florida Department of State on October 26, 1989, submits this Statement of Termination.

The general partner of the Dissolved Limited Partnership, Betty J. Morrison, passed away on December 3, 2013, and no one has been appointed general partner for and in her place. Bryan W. Paul, the Trustee of the Betty J. Morrison Irrevocable Children's Trust, is the sole limited partner of the Dissolved Limited Partnership. As Trustee of the trust he owns all of the rights to receive distributions as a limited partner.

Bryan W. Paul, as Trustee of the Betty J. Morrison Irrevocable Children's Trust, appointed Bryan W. Paul to wind up the Dissolved Limited Partnership's activities pursuant to Section 620.1803(3), Florida Statutes. Following the appointment, the Dissolved Limited Partnership's certificate of limited partnership was amended as provided in Section 620.1202(2)(c), Florida Statutes. The Amendment to Certificate of Limited Partnership was filed on May 31, 2017 (the "Amendment").

Since filing the Amendment, Bryan W. Paul has completed winding up the Dissolved Limited Partnership's affairs and wishes to file a statement of termination.
