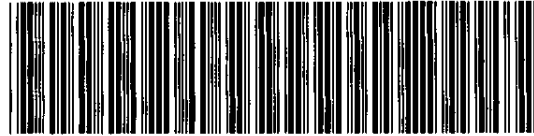

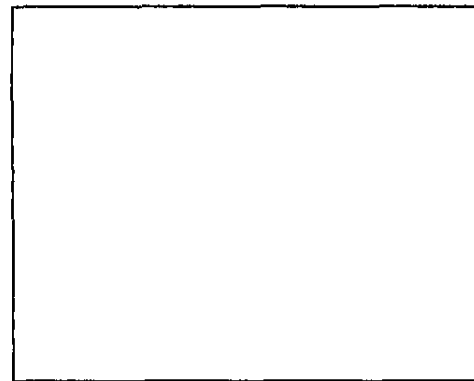

THIRD: *Defaults or erroneous information or defect is corrected as follows:*

1. The Certificate of Limited Partnership filed on March 19, 1990 at 12:50 pm identifies on the first page that the general partner is "Gerald M. Magnuson, Trustee under Trust dated 1/25/90" (hereinafter referred to as "Gerald M. Magnuson"). The successor trustee of the Gerald M. Magnuson Trust u/a/d 1/25/90 is Gerald Magnuson's son, Stewart S. Magnuson.

2. Gerald M. Magnuson died a resident of Pinellas County, Florida on December 12, 2010. Erroneously believing that the reference on the annual report to Gerald M. Magnuson appropriately was referring to the Gerald M. Magnuson Trust u/a/d 1/25/90, Stewart S. Magnuson signed the annual report as successor trustee (without disclosing his status as successor trustee) believing the same was appropriate.

3. In connection with a transfer of Pinellas County real estate owned by The Third Gerald M. Magnuson Family Limited Partnership, the title insurance company involved wants the Florida Secretary of State's records to reflect the current general partner who will be signing the deed and other closing documents.
