The undersigned being the sole general partner of Lake Lerla Limited Partnership, a Florida limited partnership, (the "Partnership") hereby this _____ day of December, 2001, approves and adopts the following partnership resolutions:

RESOLVED, that in the judgment of the General Partner of the Partnership, it is deemed advisable and for the benefit of the Partnership that it should be dissolved; and

BE IT FURTHER RESOLVED, that a plan of liquidation be, and it hereby is, formulated to effect such liquidation and dissolution in accordance with the following resolutions:

RESOLVED, that the President and Vice President of the Corporation be, and each of them acting singly hereby is, authorized and directed to file a Certificate of Cancellation with the Secretary of State of the State of Florida;

RESOLVED, that all liquid assets of the Partnership be distributed to the partners of the Partnership, in accordance with the Partnership Agreement;

RESOLVED, that the actions provided for in the foregoing resolutions providing for the complete liquidation of the Partnership and the distribution of all its assets of the commenced immediately, and that its subsequent dissolution and the distribution of all its assets be completed as soon as possible but no later than the close of business on December 31, 2001; and

RESOLVED, that the President or any Vice President of the Corporation, as general partner of the Partnership be, and each of them acting singly hereby is, authorized and directed to pay all such fees and taxes and to do or cause to be done such further acts and things as each of them may deem necessary or proper in order to carry out liquidation and dissolution of the Partnership and fully to effectuate the purposes of the foregoing resolutions.
