The sole General Partner for the Rio Towers, LTD, <u>Rio Towers, Inc.</u>, a solely and wholly owned subsidiary of East Little Havana Community Development Corporation, a Florida Non-Profit Corporation qualified as Charitable under S.501(c)(3) of the Internal Revenue Code, has converted into a Florida Limited Liability Company (LLC), under the name of <u>Rio Towers, LLC</u>, owned solely by its only and sole member, the East Little Havana Community Development Corporation, a Florida Non-Profit Corporation qualified as Charitable under S.501(c)(3) of the Internal Revenue Code.
