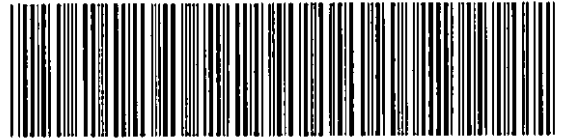



1. The Certificate of Limited Partnership and Partnership Agreement are both amended as follows:

2. This Certificate of Amendment to Certificate of Limited Partnership and Partnership Agreement shall be effective when filed by the Florida Department of State.


3. Except as expressly modified and amended herein, all other terms and conditions of the Certificate of Limited Partnership and Partnership Agreement shall remain in full force and effect.

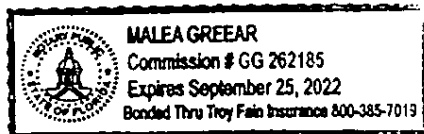


