CERTIFICATE OF CANCELLATION FOR

Paxson Broadcasting of Tampa, Limited Partnership

Pursuant to the provision of section 620.113, Florida Statutes, Paxson Broadcasting of Tampa, Limited Partnership (the "Partnership"), whose certificate of limited partnership was originally filed with the Florida Department of State on 27, 1991, hereby submits this certificate of cancellation.

FIRST: The reason for the aforementioned cancellation is that the sole general partnership interest and the sole limited partnership interest in the Partnership were transferred by operation of law to and are now held by Paxson Communications Corporation, a Delaware corporation ("PCC"), as a result of the following mergers, effective July 17, 1997.:

- a) The Partnership's sole general partner, Paxson Communications of Florida, Inc., merged into PCC;
- b) The Partnership's sole limited partner, Paxson Communications LP, Inc., also merged into PCC.

Effective on or about July 13, 1997, the Partnership elected in a manner provided by its partnership agreement and applicable law to amend its partnership agreement to provide, pursuant to Florida Statute 620.90(3), for the Partnership to be governed by Florida's Revised Uniform Partnership Act of 1995. Pursuant to Florida Statute 620.8302(9) contained within such Act, upon PCC holding all such partnership interests, all of the Partnership's property vested in PCC.

SECOND: This certificate of cancellation shall be effective at the time of its filing with the Florida Department of State.
