3. AMENDMENT. The Certificate is hereby amended as follows:



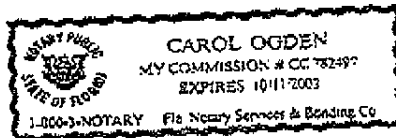
