OF LIMITED PARTNERSHIP OF RAVENWOOD OF KISSIMMEE, LTD.**



This Amended Certificate amends, restates and supersedes, in its entirety, that certain Certificate of Limited Partnership Agreement for Ravenwood of Kissimmee, Ltd. filed with the Florida Department of State on December 4, 1991, as supplemented and amended by that certain First Amendment to the Certificate of Limited Partnership Agreement for Ravenwood of Kissimmee, Ltd. filed with the Florida Department of State on February 8, 1993, and as amended and restated by that certain Supplemental Affidavit and Amended and Restated Certificate of Limited Partnership for Ravenwood of Kissimmee, Ltd. filed with the Florida Department of State on September 27, 1994. This Amended Certificate shall be effective upon the date of the filing thereof with the Florida Department of State (the "Effective Date").

1. The name of the Limited Partnership is Ravenwood of Kissimmee, Ltd.


