CONCAP VILLAGE GREEN ASSOCIATES, LTD. AMENDMENT TO AGREEMENT OF LIMITED PARTNERSHIP

This Agreement is made and entered into effective as of the 31 51 day of December, 1997 by and among ConCap CCP/III Properties, Inc., a Texas corporation, having an office at One Insignia Financial Plaza, Greenville, SC 29601 (the "Withdrawing General Partner"), CCP/III Village Green GP, Inc., a South Carolina corporation, having an office at One Insignia Financial Plaza, Greenville, SC 29601 (the "General Partner"), and Consolidated Capital Properties III, a California limited partnership, having an office at One Insignia Financial Plaza, Greenville, SC 29601 (the "Limited Partner"). The Withdrawing General Partner, the General Partner, and the Limited Partner are hereinafter sometimes referred to collectively as the "Partners" and individually as "Partner".

RECITALS:

The Withdrawing General Partner and the Limited Partner previously entered into an Agreement of Limited Partnership of ConCap Village Green Associates, Ltd., a Texas limited partnership (the "Partnership") dated as of December 12, 1991 (the "Partnership Agreement").

The parties hereto are desirous of amending the Partnership Agreement to reflect the admission of CCP/III Village Green GP, Inc. as the General Partner in the place and stead of ConCap CCP/III Properties, Inc.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained, the parties hereto, each intending to be legally bound, hereby amend the Partnership Agreement as follows:

- 1. CCP/III Village Green GP, Inc. is hereby admitted to the Partnership as the General Partner. ConCap CCP/III Properties, Inc. hereby withdraws from the Partnership. Wherever "General Partner" is referred to in the Partnership Agreement, such term shall refer to CCP/III Village Green GP, Inc.
- 2. Except as specifically amended as provided herein, the provisions of the Partnership Agreement shall remain unchanged and in full force and effect.
