This letter is a follow-up to our telephone conversation of March 15, 2000 relating to filing and your letter of March 10, 2000, a copy of which is enclosed. Firstly, please accept my apology for the delay in this response.

As we discussed, the background of this matter is that two individuals were incorrectly added as general partners on a prior year's annual limited partnership return. These individuals, namely Bernard F. Silver and Lawrence A. Silver have never been and are not now general partners of this Partnership. Furthermore, Florida law does not allow them to be added as general partners merely by adding their name (incorrectly) to an annual limited partnership return.


