2. Except as expressly provided herein, all of the terms and provisions of the Certificate shall remain in full force and effect and are hereby ratified and confirmed.


3. This Amendment is being filed within thirty (30) days after the withdrawal of Robert K. Fletcher as a General Partner] which occurred on October 25, 2000.




