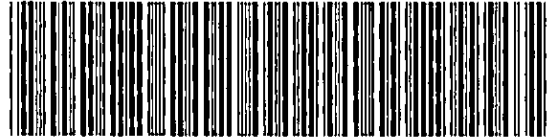




WHEREAS, this Certificate of Dissolution shall become effective as of the date of the Administrative Dissolution
