Dear Mr. Rivers:

I appreciate you taking my call this morning. The continuing difficulty involving late charges for the (2) Southern Acres entities is a source of distress. I implore the Division to waive the penalty for the following reasons:

Fact: All bills for Southern Acres entities are paid by me, out of accounts belonging to our bank holding company, Merchants & Southern Banks of Florida, Inc. Such accounts have ample balances and revenues, which are verifiable and, perhaps, examined by examiners from the Division of Banking on a periodic basis. I mean to imply that the amount of such bills is miniscule and we would have no financial or other reason to delay payment and consistently receive late payment assessments.

Fact: I, as CFO, always pay such bills within 48 hours of receipt. Further, I have no way to prove to the Division - my date of receipt.

Fact: The late notices do not indicate that they are "second notices". I get them and pay them. However, if clearly marked "Late Notice" our contact would be immediate, as in the case of my response to your letter.

Statement of Fact: I have received no previous filing notice to the one attached. We paid it within days of receipt (I see no date of issuance of this notice). The fact that our payment was late can only, in my opinion, be explained by "a non receipt of the original notice". I have indicated, as best possible, that mail should be sent to my attention.

Please accept this request to waive any late penalty concerning this UBR. We would appreciate notice of your decision.
