




AGREEMENT

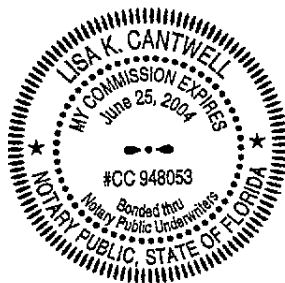
