The following Plan of Merger, which was adopted and approved by each party to the merger in accordance with Section 620.202, is being submitted in accordance with Section 620.201 of the Florida Statutes.

FIRST: The exact name and jurisdiction of each merging party are as follows:

Pursuant to that certain Agreement and Plan of Merger (the "Merger Agreement") dated as of August 9, 2004, by and among U.S. Restaurant Properties, Inc., a Maryland corporation (the "Company"), Ivanhoe Acquisition XIV, LLC, a Maryland limited liability company ("Acquisition LLC") and CNL Income Fund XIV, Ltd., a Florida limited partnership (the "Fund"), Acquisition LLC, an indirect wholly-owned subsidiary of the Company, will be merged with and into the Fund and the Fund will be the surviving entity in the merger (the "Merger").
