BEFORE ME, the undersigned authority, this day personally appeared **Roy D. Oppenheim**, who, after being duly sworn, deposes and says:

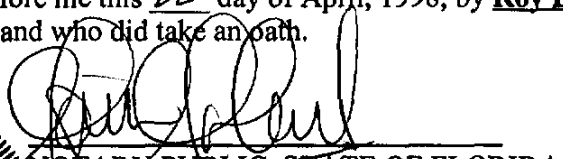
1. That I am **Roy D. Oppenheim**;
