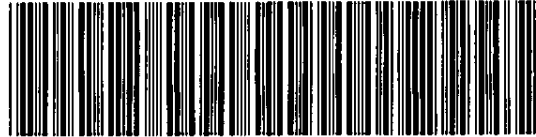




5. *In accordance with Section 620.1104, F.S., the Partnership shall have a perpetual duration.*
