### Amendment to Certificate of Limited Partnership

This Amendment to Certificate of Limited Partnership for **Doctors' Medical Plaza Associates, Ltd.**, executed January 29, 1993, filed with the Secretary of State on February 17, 1993 as document number A93000000178.

The Certificate of Limited Partnership for Doctors' Medical Plaza Associates, Ltd. is amended in the following particulars:

1. Doctors' Medical Plaza, Inc. is removed as the General Partner by vote of the Limited Partners holding not less than 2/3s of the Units pursuant to paragraph 5.11 of the Limited Partnership Agreement; the Limited Partners elect to continue the business of the Partnership and appoint a new General Partner, Doctors' Medical Plaza Management Company of Pinellas County, Inc., by Majority Vote, pursuant to paragraph 12 of the Limited Partnership Agreement. All references to the General Partner in the Certificate of Limited Partnership shall mean Doctors' Medical Plaza Management Company of Pinellas County, Inc.
2. The effective date of the appointment is December 19, 1997.
3. The substituted General Partner is assigned as its partnership interest the interest of the removed General Partner.
