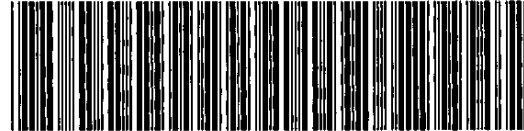


As we discussed, I am enclosing this firm's check in the amount of \$210. This check represents payment for:




1. The name of the Partnership shall be: DLF-NEC, LLLP.
