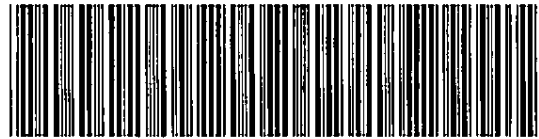


1. Name. The name of this limited Partnership is "DJ & N, Ltd."

3. Amendment. Paragraph 3 of the Certificate of Limited Partnership shall be deleted in its entirety, and the following shall be inserted in its stead:



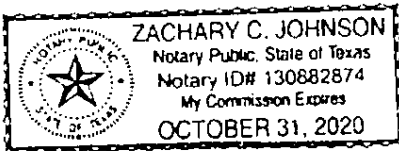
