

**JUNE 2007 AMENDMENT TO THE AMENDMENT
AND RESTATEMENT OF THE LIMITED PARTNERSHIP
AGREEMENT AND CERTIFICATE OF LIMITED
PARTNERSHIP OF NORTHWEST FLORIDA SURGERY CENTER, LTD.**

THIS AMENDMENT of the Limited Partnership Agreement and Certificate of Limited Partnership of Northwest Florida Surgery Center, Ltd. shall become effective on its filing with the Department of State, State of Florida, by and among the Northwest Florida Surgery Center, Inc., a Florida corporation, the Managing General Partner, and each of the Limited Partners.

ARTICLE I

Section 10.7 is amended to read:

Each Limited Partner agrees that (i) at least one-third of his medical practice income from all sources for each Fiscal Year will be derived from such Limited Partner's performance of Procedures and (ii) at least one-third of Procedures performed by such Limited Partner for each Fiscal Year will be performed at the Surgery Center (collectively, the "One-Third/One-Third Test"). Commencing January 2004, for the calendar year 2003, each Limited Partner agrees to provide the Partnership with an executed and acknowledged affidavit within thirty (30) days of the end of each Fiscal Year stating that he has fully complied with the One-Third/One-Third Test for the preceding Fiscal Year (the "Affidavit"). If a Limited Partner fails to provide the Affidavit to the Partnership within the time period specified above, such Limited Partner shall be required to sell his Partnership Interest to the Partnership pursuant to the terms of Section 11 as amended.

ARTICLE II

Section 11.7 (b) (x) is amended to read:

(x) A Limited Partner's Retirement. Retirement for purposes of this paragraph is defined as the Limited Partner's: (a) total withdrawal from the practice of medicine in Bay County, Florida; (b) reduction from his or her medical practice by not accepting new patients on an ongoing and frequent basis; (c) reduction of a Limited Partner's participation in his or her medical practice in Bay County, Florida, to twenty (20) hours or less a week, for a continuous period of more than two (2) months, without receiving approval by a unanimous vote of the Board of Directors; or (d) reduction in the number of procedures or surgeries performed by a Limited Partner at the Northwest Florida Surgery Center to less than 144 cases within any twelve (12) consecutive months. The Board, upon an approving 2/3 vote, may waive the required number of procedures or surgeries within any twelve (12) consecutive months, but only for good cause shown, i.e., sickness, etc. For purposes of clarification, multiple surgeries or procedures on the same patient on any one day shall count as a single procedure or surgery. If the Limited Partner whose status is an issue is on the Board of Directors, that Limited Partner shall not be entitled to vote on whether he or she shall be considered retired from the active practice of medicine.

ARTICLE III

Section 11.7 (b) (xi) is amended to read:

- (xi) Failure to meet the One-Third/One-Third Test requirement.

ARTICLE IV

Section 11.7 (b) is amended to include the following additional subparagraphs:

(xii) By unanimous vote of the Limited Partners, excluding the Limited Partner whose status is at issue.

(xiii) Expulsion. The ownership interest of a Limited Partner may be terminated by a unanimous vote of the remaining Limited Partners.

ARTICLE V

Section 11.7 is amended to include subparagraph (c):

(c) Should the existence of a terminating event or the retirement of a limited Partner come into question, the Board of Directors (the "Board") shall have the right to require and the Limited Partner shall have the obligation to produce his or her office records that bears on the issue. The failure of a Limited Partner to produce the requested records within thirty (30) days after the request of the Board for them shall constitute a terminating event and one that cannot be cured except by a unanimous vote of the Board Members.

ARTICLE V

All terms and provisions of the Limited Partnership Agreement and Certificate of Limited Partnership of Northwest Florida Surgery Center, Ltd., and the Amendments thereto are hereby confirmed except as modified hereby.
