AMENDMENT TO

AMENDED AND RESTATED LIMITED PARTNERSHIP AGREEMENT

THIS AMENDMENT to the Amended and Restated Limited Partnership Agreement dated May 6, 1996 by and between American Title of the Southeast, Inc., a Florida corporation, as general partner, and D and S of South Florida Holdings, Ltd., a Florida limited partnership, as limited partner ("Limited Partnership Agreement") is made this <u>16th</u> day of December, 1998.

RECITALS

WHEREAS, on May 6, 1996 the above described parties entered into an Amended and Restated Limited Partnership Agreement to reform and restate the limited partnership known as American Title of the Palm Beaches, Ltd. ("American Title"); and

WHEREAS, pursuant to Article XII, Paragraph 12.1 of the Limited Partnership Agreement, a limited partner may, without the written consent of the general partner, assign its interest in the Partnership to any other person or entity, and

WHEREAS, D and S of South Florida Holdings, Ltd. did assign its interest in and to American Title to Pulte Diversified Companies, Inc., a Michigan corporation, and

WHEREAS, pursuant to Article XII, Paragraph 12.2 of the Limited Partnership Agreement, additional general partners may be admitted to the partnership on such terms as may be agreed upon in writing by all of the partners and such new partners, and

WHEREAS, the partners wish to add American Title of the Palm Beaches Acquisition Corp., a Michigan corporation as a new general partner,

NOW THEREFORE for and in consideration of \$10.00 and other good and valuable consideration, including the terms and covenants described herein, the receipt and sufficiency of which consideration the parties have accepted, it is agreed as follows:

- 1. <u>Recitals</u>. The parties agree that the foregoing recitals are true and correct; and shall be incorporated herein.
- 2. Additional General Partner. The parties hereto agree that American Title of the Palm Beaches Acquisition Corp., a Michigan corporation authorized to transact business in the State of Florida, shall be admitted to American Title as a new general partner, and that a Certificate of Amendment to the Amended and Restated Limited Partnership Agreement for American Title of the Palm Beaches, Ltd.

("Certificate of Amendment") shall be promptly filed with the Florida Secretary of State evidencing the addition of the new general partner. The parties further agree that the present general partner, American Title of the Southeast, Inc., a Florida corporation, shall withdraw as a general partner of American Title effective on the date of filing of the Certificate of Amendment.

Miscellaneous Corrections. The parties further agree that the Certificate of Amendment shall name the successor Registered Agent for American Title and shall make such other revisions as may be necessary or appropriate to the certificate of limited partnership of American Title.
