

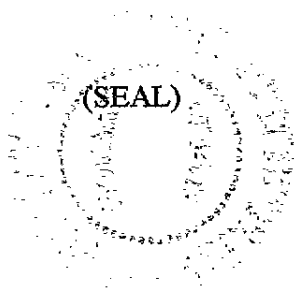

SECOND AMENDMENT
TO
CERTIFICATE OF LIMITED PARTNERSHIP
OF
CENTURION INVESTORS LIMITED PARTNERSHIP

THIS SECOND AMENDMENT is made and entered into for purposes and in all respects as of the 15th day of May 2000 by and among the undersigned parties.

A. Centurion Investors Limited Partnership (the "Partnership") is a Florida limited partnership formed and presently existing pursuant to a Certificate of Limited Partnership (the "Certificate"). The Certificate was filed with the Florida Secretary of State's office on September 8, 1993, as document #A93000000913.

B. Pursuant to an understanding among the partners of the Partnership, they have agreed to admit Gary Barrett as a limited partner with a 15% limited partnership interest in the Partnership, and each partner, except Dave Turner, has agreed to reduce his or her limited partnership interest in the Partnership by five percentage points.

C. The parties hereto desire to amend the Certificate of the Partnership to reflect the aforesaid admission of Gary Barrett as a limited partner and the reduction of the other partners' limited partnership interests, with the exception of David Turner whose interest will remain the same.

NOW, THEREFORE, for the good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned parties agree and certify that the Certificate of the Partnership is hereby amended to provide as follows:

1. Exhibit A of the Certificate is hereby amended to delete the present Exhibit A and to insert in lieu thereof the Exhibit A appended hereto and incorporated herein by this reference.

2. It is further provided and agreed that (i) Gary Barrett shall be and hereby is substituted as a Limited Partner of the Partnership to the full extent of a 15% Limited Partnership Interest in the Partnership; (ii) the signing of this Second Amendment by the General Partner and each Limited Partner of the Partnership does and shall constitute the consent of each Partner to said admission of Gary Barrett as a Limited Partner; (iii) any present or future references to the terms "partner(s)" or "limited partner(s)" by the Certificate, or any amendment thereto, shall be deemed to include Gary Barrett to the extent of the 15% Limited Partnership Interest in the Partnership transferred to him; and (iv) the execution of this Second Amendment by Gary Barrett shall constitute his agreement to all of the terms and provisions of the Certificate, as amended.

3. Except as hereby amended, the Certificate is ratified and affirmed in all respects.

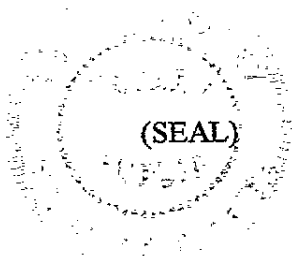

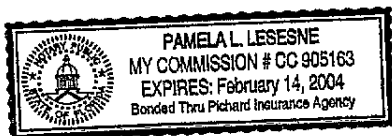

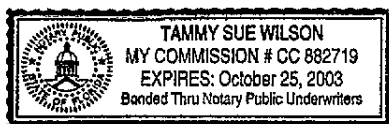
