FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

This action was heard by the Court on December 13, 2000. On the evidence presented,

IT IS ORDERED AND ADJUDGED as follows:

1. **Dissolution of Marriage.** The bonds of marriage between the Husband, LANCE EDWARD LEININGER, and Wife, KRISTINE JENKINS LEININGER, are dissolved because the marriage is irretrievably broken.

2. **Marital Settlement Agreement.** The Marital Settlement Agreement entered into between the parties and filed with the Court on November 29, 2000, is confirmed, approved, and incorporated in this Final Judgment as if fully set forth verbatim; and the parties are ordered to comply with the terms.

3. **Child Support.** The parties have agreed to child support in an amount less than the guidelines. This is in the best interests of the minor children given the division of marital assets, the financial obligations under the Agreement, and the children's needs.

4. Wife's Name. The Wife's former name of KRISTINE ELLYN JENKINS is restored.

5. Jurisdiction. This Court retains jurisdiction in this cause to enforce or modify this judgment to the full extent of Chapter 61, FLA. STAT. (1999) as permitted by the parties' Marital Settlement Agreement;
