We are the accountants for the above referenced partnership. We are writing this letter at the partnership's request with regard to penalties on the annual fees for 1999, 2000, and 2001. Enclosed please find the partnership's 2001 Uniform Business Report as well as payment of \$1,578.75, which represents payment of annual fees for 1999, 2000, and 2001. We feel the partnership's previous circumstances warrant an abatement of penalties due to reasonable cause.

The partnership delegated the responsibility for filing the annual reports to its Certified Public Accounting firm, which it relied on for all tax matters. The Firm continuously assured the Company that filings were being prepared for timely filing.

At the time when the Company should have received its Uniform Business Report, it experienced a change in registered agents as indicated on the enclosed report. The Company never received the form. As a result, and miscommunications between the Company and its CPA firm, the report was inadvertently not filed. This occurred for a second year before the Company realized the problem. The Company immediately fired its outside CPA firm and engaged us to straighten out its tax matters.


