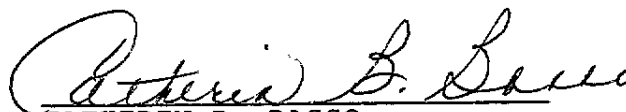
3. Amendment. The withdrawal of general partners Raymond P. Basso and Catherin B. Basso.
