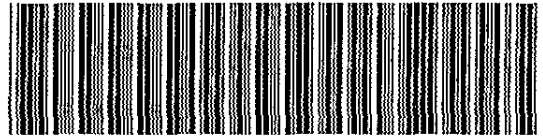

Pursuant to the provisions of section 620.109, Florida Statutes, this Florida limited partnership whose certificate was filed with the Florida Dept. of State on February 14, 1994, adopts the following certificate of amendment to its certificate of limited partnership.

Amend:

- 1.12 The Exhibit A referred to in this Article II, Section 1.12 should be amended to Corim, Inc. as both the General Partner and the Limited Partner.
- 2.02. The General Partner may, at any time and from time to time, change the location of the Partnership's principle place of business, and may establish such additional place or places of business of the Partnership as they may from time to time determine.
- 2.04 The existence of the Partnership shall commence upon the date of the original Agreement dated February 10, 1994 and shall continue for a term expiring December 31, 2008, unless sooner terminated in accordance with Article X hereof, or as otherwise provided by law.
