# SECOND AMENDMENT

TO

### AMENDED AND RESTATED AGREEMENT OF LIMITED PARTNERSHIP

AND

#### CERTIFICATE OF LIMITED PARTNERSHIP OF

EMERALD PLACE APARTMENTS OF BREVARD, LTD.

THIS SECOND AMENDMENT is made and entered into for all purposes and in all respects as of the 1st day of April, 2001, by and among the undersigned parties.

#### RECITALS:

- EMERALD PLACE APARTMENTS OF BREVARD, LTD. (the "Partnership") is Α. a Florida limited partnership presently existing pursuant to an Amended and Restated Agreement of Limited Partnership and an Amended and Restated Certificate of Limited Partnership filed on November 30, 1995 (hereinafter referred to as the "Partnership Agreement"). The Partnership Agreement has been amended pursuant to a First Amendment filed December 8, 1995.
- Pursuant to an Agreement of Assignment and Acceptance, Royal American В. Development, Inc., as Assignor, transferred and assigned its 1.0% general partnership interest in the Partnership to First Spectrum, Inc., as Assignee. The Assignor desires that the Assignee be substituted as the General Partner of the Partnership to the extent of the 1.0% limited partnership interest assigned to the Assignee by the Assignor
- The parties hereto desire to amend the Partnership Agreement to reflect the C. aforesaid transfer of general partnership interest and the substitution of the Assignee as the General Partner of the Partnership.
- NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned parties agree and certify that the Partnership Agreement is hereby amended to provide as follows:
- Schedule A of the Partnership Agreement is hereby amended to delete the present Schedule A and to insert in lieu thereof the Schedule A attached hereto and incorporated herein by this reference.
- It is further provided and agreed that (i) First Spectrum, Inc., shall be and hereby is the substitute General Partner of the Partnership to the full extent of the 1.0% general partner interest assigned to it by the Assignor; (ii) the signing of this Second Amendment by the partners (both general and limited) does and shall constitute the consent of each partner to said assignment and substitution; (iii) any present or future references to the terms "Partner(s)" or

"General Partner(s)" by the Partnership Agreement, or any amendment thereto, shall be deemed to include First Spectrum, Inc. to the extent of the 1.0% general partnership interest assigned to it by the Assignor; and (iv) the execution of this Amendment by First Spectrum, Inc. shall constitute the agreement of First Spectrum, Inc. to all of the terms and provisions of the Limited Partnership Agreement and Certificate of Limited Partnership of the Partnership, as amended.

4. Except as hereby amended, the Partnership Agreement, as amended, is ratified and affirmed in all respects.
