**FIFTH AMENDMENT TO  
LIMITED PARTNERSHIP CERTIFICATE**

The undersigned, constituting all of the partners of LECESSÉ WICKHAM ASSOCIATES, LTD. Hereby make and file, in accordance with Section 620.109 of the Florida Revised Uniform Limited Partnership Act (1986), this Amended and Restated Certificate of Limited Partnership for LECESSÉ WICKHAM ASSOCIATES, LTD. (the "Partnership"), which amends and restates the original Certificate of Limited Partnership of the Partnership filed with the Department of State of the State of Florida on February 23, 1994 (the "Original Certificate"), which Original Certificate was amended pursuant to a First Amendment to Limited Partnership Certified filed with the Department of State of the State of Florida on June 15, 1994 (the "First Amendment"), which was further amended pursuant to a Second Amendment to Limited Partnership Certificate filed with the Department of State of the State of Florida on June 28, 1996 (the "Second Amendment"), which was further amended pursuant to a Third Amendment to Limited Partnership Certificate filed with the Department of State of the State of Florida on \_\_\_\_\_ (the "Third Amendment"), which was further amended pursuant to a Fourth Amendment to Limited Partnership Certificate filed with the Department of State of the State of Florida on April 1, 1997 (the "Fourth Amendment").

The Original Certificate, the First Amendment, the Second Amendment, the Third Amendment and the Fourth Amendment are hereby amended (i) to include the addition of one (1) Limited Partner; (ii) the withdrawal of the Limited Partner; and (iii) to reflect the change in ownership interest of the partnership.

Paragraph 4 of the Limited Partnership Certificate as amended by the First Amendment, the Second Amendment, the Third Amendment and the Fourth Amendment shall be deleted and the following shall be inserted in its place:
