**CERTIFICATE OF AMENDMENT OF LIMITED PARTNERSHIP  
OF**

**SUNSHINE PORTFOLIO, LTD. I**

a Florida limited partnership

1. The name of the limited partnership is Sunshine Portfolio, Ltd. ("Partnership").

2. The certificate of limited partnership of the Partnership was filed with the Florida Department of State on March 10, 1994.

3. The powers of the General Partner to take certain actions on behalf of the Partnership are restricted under the provisions of that certain Limited Partnership Agreement of the Partnership, dated March 11, 1994 (the "Agreement"), absent the prior written consent of the Class B Limited Partner, which consent may be withheld in the sole discretion of the Class B Limited Partner, including, without limitation, restrictions contained in Sections 5.2 and 5.5 of the Agreement, and in particular the following restriction:

5.2(h) create, assume, incur, or cause the Partnership to become liable in respect of, any contractual indebtedness for money borrowed, including, without limitation, pursuant to any "future advance" clause under any instrument, other than as provided for in a budget prepared by the General Partner and approved in writing by the Class B Limited Partner.

4. The Class A Limited Partner shall not, without the prior written consent of PRN Investments ("PRN") (which consent may be withheld in the sole discretion of PRN) voluntarily, involuntarily, by operation of law, or otherwise, transfer pledge, mortgage, encumber or subject to any lien, pledge, claim or encumbrance of any type or nature, all or any part of its Interest during the time that the Class A Limited Partner has any obligations outstanding under that certain Guaranty Agreement, dated March 11, 1994, made by the Class A Limited Partner in favor of PRN. Capitalized terms not otherwise defined shall have the meanings set forth in the Agreement.

IN WITNESS WHEREOF, the undersigned general partner of Sunshine Portfolio, Ltd. I has executed this Certificate of Amendment of Limited Partnership this 11th day of March, 1994.


