## AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT

This Amendment to Limited Partnership Agreement (this "*Amendment*") is executed by A-1 Rapid Storage, L. C., a Florida limited liability company, AAA On-Site Storage, Inc., a Florida corporation, Stephen J. Baseman, and Joseph D. Zigulich, Jr., constituting all the general and limited partners of A-1 Trailer Rental, Ltd. (the "*Partnership*"), a Florida limited partnership, to record their following agreement regarding an amendment to the Agreement of Limited Partnership of A-1 Trailer Rental, Ltd. dated March 10, 1994 (the "*Partnership Agreement*");

1. **Change of Partnership Name.** Section 1 of the Partnership Agreement is amended to change the name of the limited partnership to "Lincoln Holding, Ltd." 3. **Continued Effectiveness; Effective Date.** Except as expressly modified by this Amendment, the Partnership Agreement will continue in full force and effect. This Amendment will become effective as of April 19, 2000, when it is executed by all the Partners of the Partnership.
