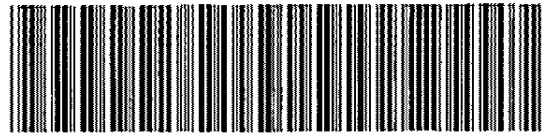

Pursuant to the provisions of Section 620.109, Florida Statutes, this Florida limited partnership, whose certificate was filed with the Florida Department of State on March 23, 1994, adopts the following certificate of amendment to its Certificate of Limited Partnership.

FIRST: The purpose of the limited partnership shall be as hereinafter set forth:

Limited Purpose. For so long as any portion of the Loan (hereinafter defined) is outstanding, the Partnership's purpose shall be solely limited to (i) owning, holding, selling, leasing, transferring, exchanging, operating and managing the subject property, (ii) entering into the loan documents with Bank of America, N.A. (hereinafter referred to as the "Lender"), (iii) refinancing the subject property in connection with a permitted repayment of the loan from the Lender in the principal amount of \$8,400,000.00 (the "Loan") to Gull House Limited No. 2, a Florida limited partnership, Gull House Limited No. 7, a Florida limited partnership and Gull House Limited No. 14, a Florida limited partnership (hereinafter collectively referred to as the "Borrower"), and (iv) transacting any and all lawful business for which an entity may be organized under its constitutive law that is incident, necessary and appropriate to accomplish the foregoing.

SECOND: Effective Date: This certificate of amendment shall be effective at the time of its filing with the Florida Department of State.
