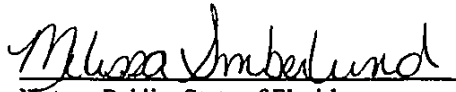

Recitals:

- A. Creative Choice Homes X, Ltd. (the "Partnership") was previously formed as a Florida limited partnership by Certificate of Limited Partnership, dated March 22, 1994 and filed with the Florida Secretary of State on March 22, 1994 as amended by Certificate of Amendment filed August 29, 1994 and Certificate of Amendment dated August 31, 1995 (as amended the "Original Certificate");
- B. The affairs of the Partnership are now governed by a second Amended and Restated Limited Partnership Agreement, dated as of November 22, 1996 (the "Partnership Agreement"); and
- C. It is appropriate to amend and restate the Original Certificate as follows:
 - 1. The name of the Partnership is Creative Choice Homes X, Ltd.
