## SECOND AMENDMENT TO AGREEMENT OF LIMITED PARTNERSHIP FOR SEMBLER FAMILY PARTNERSHIP #9, LTD.

THIS AGREEMENT, executed as of the day of day of day, 1997, by and among SEMBLER CENTERS, INC. ("General Partner"), a Florida corporation, MELVIN F. SEMBLER, BRENT W. SEMBLER, GREGORY S. SEMBLER, CRAIG SHER, DENNIS M. SHEEHAN, JEFFREY S. FUQUA, and the TAMPA ORLANDO PINELLAS JEWISH FOUNDATION, INC., a Florida corporation (collectively, "Limited Partners").

## WITNESSETH:

WHEREAS, the original partners of SEMBLER FAMILY PARTNERSHIP #9, LTD. (the "Partnership") have executed that certain Agreement of Limited Partnership dated September 7, 1993 ("Partnership Agreement");

WHEREAS, the Partnership Agreement was amended by a separate written amendment executed by the partners of the Partnership on January 11, 1994;

WHEREAS, certain of the Limited Partners assigned portions of their interests in the Partnership to TAMPA ORLANDO PINELLAS JEWISH FOUNDATION, INC. ("TOPJF") on or about \_\_\_\_\_\_\_, 1997 and thereby admitting TOPJF as an additional limited partner of the Partnership;

WHEREAS, the partners of the Partnership desire to further amend the Partnership Agreement to acknowledge the admission of TOPJF as a Limited Partner and to set forth the agreement for the allocation of income, loss and cash flow; and

WHEREAS, the partners of the Partnership desire to reduce to writing the amendments to the Partnership Agreement.

  - (d) The invalidity or unenforceability of any provision hereof shall not affect the other provisions hereof, and this Agreement shall be construed in all respects as if such invalid or unenforceable provision were omitted.
  - (e) No waiver of any breach hereof shall constitute a waiver of any subsequent breach hereof.
