1. The following provisions of the Limited Partnership Certificate of Lucky Start, A Limited Partnership, a Florida limited partnership, a Florida limited partnership, filed in Tallahassee, Florida, on April 5, 1994, be and they hereby are amended in the following particulars:

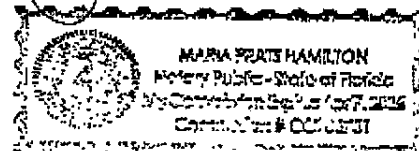
