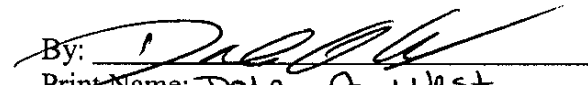
3. Reason for Filing Certificate of Cancellation. This Certificate of Cancellation is being filed due to the dissolution and the completion of winding up of the Partnership.
