This Certificate is made this 14th day of June, 1999, by Earl Harvey Archer III who together with Elva L. Weiss and William Gresham McArdle, Jr., are the Trustees of the Elva L. Weiss Trust dated November 26, 1986, as amended (the "Elva L. Weiss Trust"). The undersigned is executing this Certificate on behalf of Elva L. Weiss and William Gresham McArdle, Jr. (the "Co-Trustees"), under the attached Delegation of Authority dated May 19, 1994, which is in full force and effect as of the date of this Certificate. The undersigned as Trustee, for himself and the Co-Trustees, certifies as follows:

1. The name of the limited partnership is the Lavies Family Limited Partnership (the "Partnership").
2. The Certificate of Limited Partnership was filed on May 24, 1994.
3. Section 13.1(c) of the Agreement of Limited Partnership of Lavies Family Limited Partnership, dated as of May 1994, as amended (the "Partnership Agreement"), provides that the Partnership shall be dissolved, wound up, and liquidated upon an affirmative vote of the General Partner and a majority of the Limited Partners. An affirmative vote of the General Partner and majority of the Limited Partners has occurred. Section 620.157(2) of the Florida Statutes, provides that a limited partnership is dissolved upon the happening of an event specified in writing in the partnership agreement. A dissolution event specified in the Partnership Agreement has occurred.

4. This certificate of cancellation shall be effective at the time of its filing with the Florida Department of State.

ELVA L. WEISS TRUST

DELEGATION OF AUTHORITY

WHEREAS the Elva L. Weiss Trust was established by a Trust Agreement dated November 26, 1986 by Elva L. Weiss, as Settlor, and Elva L. Weiss and Earl Harvey Archer, III, as Trustees; and

WHEREAS the Settlor has amended the Elva L. Weiss Trust Agreement dated November 26, 1986 by a First Amendment dated October 23, 1990; by a Second Amendment dated December 20, 1990; by a Third Amendment dated July 22, 1991; by a Fourth Amendment dated February 7, 1992; by a Fifth Amendment dated April 13, 1992; by a Sixth Amendment dated May 7, 1993 and by a Seventh Amendment dated May 19, 1994 (collectively the "Elva L. Weiss Trust, as amended"); and

WHEREAS the Elva L. Weiss Trust, as amended, provides in Paragraph 8, Section H as follows:

Any Trustee may by a written instrument delegate to any Co-Trustee the ability to act for such Trustee and any action taken pursuant to such delegation shall be valid for all purposes as if done by the Trustee making such delegation. Any such delegation may be general or limited to certain acts or may contain conditions and restrictions and may be changed or revoked in the manner specified in the written instrument of delegation or, if no other manner is specified, may be changed or revoked at any time by the Trustee who made such delegation giving written notice of its change or revocation to the Co-Trustee; and

WHEREAS Elva L. Weiss, Earl Harvey Archer, III, and William Gresham McArdle, Jr., as Trustees of the Elva L. Weiss Trust, as

amended, (the "Trustees") are the General Partner of the Lavies Family Limited Partnership, a Florida Limited Partnership; and

WHEREAS Elva L. Weiss, as Trustee, and William Gresham McArdle, Jr., as Trustee, (collectively the "Co-Trustees") wish to delegate to Earl Harvey Archer, III, as Trustee, all of their rights and powers as Co-Trustees to act as General Partner of the Lavies Family Limited Partnership; and

WHEREAS the Co-Trustees reserve the right to amend or revoke this delegation of authority (the "Delegation of Authority") Earl Harvey Archer, III, as Trustee.

NOW, THEREFORE:

1. Elva L. Weiss and William Gresham McArdle, Jr., as Co-Trustees, delegate to Earl Harvey Archer, III, as Trustee, all of their rights and powers as Co-Trustees to act as General Partner of the Lavies Family Limited Partnership to the end that Earl Harvey Archer, III, as Trustee, shall have the entire authority of the Trustees to act as General Partner of the Lavies Family Limited Partnership with the sole and exclusive right to manage the Partnership with all of the rights and powers that may be possessed by a general partner under the Florida Revised Uniform Limited Partnership Act (1986) as amended from time to time or any corresponding provisions of succeeding law.

2. Elva L. Weiss and William Gresham McArdle, Jr., as Co-Trustees, for the purpose of inducing third parties to act in accordance with the rights, powers and authority delegated to Earl H. Archer, III, as Trustee, by this Delegation of Authority,



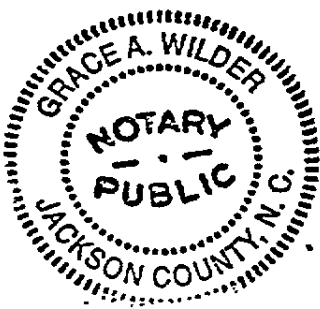
