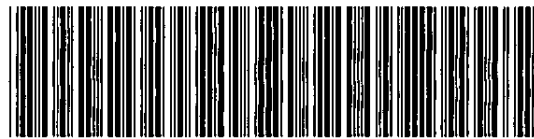

Dear Sirs:

The IRS Section 29 Biomass Gasification Tax Credit expired on 12/31/07 and, per Coastal Forest Resource Company's CPA, will not be renewed. Therefore, HSP is hereby dissolved per Article 10 of the Agreement Of Limited Partnership (copy attached).

Coastal Forest Resources Company has bought HSP's physical assets for \$150,000, which is equal to the original capital contributions made by Havana Boiler Company (\$118,500) and Hurst Energy, Inc. (\$31,500). HSP's final cash balance, after payment and discharge of all debts and liabilities is distributed herewith to the Limited Partners in proportion to their capital accounts and are equal to the original capital contribution amounts.

These distributions are return of capital and are not taxable.
