Pursuant to the provisions of Section 620.109, Florida Statutes, this Amendment to Certificate of Limited Partnership ("Amendment") of Adanson Limited Partnership, a Florida limited partnership (the "Partnership") is made and entered into by Adanson Corporation, as the general partner of the Partnership and each of the limited partners of the Partnership who have executed this Amendment and is intended to evidence the mutual agreement of the parties hereto to amend the Certificate of Limited Partnership of Adanson Limited Partnership filed with the Florida Department of State on September 20, 1994 (the "Certificate").

For and in consideration of the mutual covenants and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Article Three of the Certificate is hereby amended to read in its entirety as follows:

PURPOSE

The sole purpose of this Limited Partnership is to acquire, own, use, improve, lease, manage, operate, mortgage, sell, and otherwise deal with all or any part of the Adanson Business Center located at 5125 and 5135 Adanson Street, Orlando, Florida and all pertinent real property, personal property, contract rights and other intangibles used in the operation thereof (the "Project") and hold the Project for appreciation and investment purposes. The Partnership may engage in any and all general business activities related to and incidental to such purpose.

2. Except as hereby amended, the Certificate shall remain in full force and effect.

3. This Amendment shall be effective as of the date it is filed with the Florida Department of State.

4. This Amendment may be executed in counterparts.

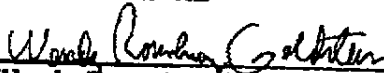
