

Enclosed is our Application for Reinstatement for Limited Partnership. Our application does not include a check for the \$500 penalty, because we believe that there has been two clerical errors on your part.

1. We did not receive a 60 day notice of intent to revoke. Possibly, you consider the red warning on the top of the Annual Report as 60 day notice of intent to revoke. Even if this was the warning, we respectfully bring to your attention that we did timely file.
2. Our original Annual Report was rejected due to a clerical error on our part. You gave us 30 days to respond. You waited only 14 days then sent us a Certificate of Revocation. We were confused by your actions, so, after receiving your Certificate of Revocation we took time to consult with our attorney. This is why this return communications has taken more than the allotted 30 days.

The timing details are as follows: Our original Annual Report was timely filed on April 4, 1997. We had a clerical error on line 5b of that report. On April 9, 1997 you returned our original application and check and gave us 30 days to respond. Instead of waiting for 30 days, you sent us a Certificate of Revocation on April 23, 1997.

Thank you for your consideration of our request for abatement.
