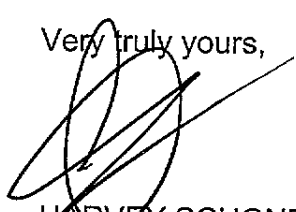

On January 6, 1995, the De Guzman Family Limited Partnership executed and filed its Certificate of Limited Partnership with the State of Florida, pursuant to the Florida Revised Uniform Limited Partnership Act. That Certificate of Limited Partnership designated BERNABE J. DeGUZMAN as the partner to maintain the financial and tax records and BERNABE J. DeGUZMAN and MARY DeGUZMAN as general partners. The Certificate further names JEANETTE Y. VALENTI as successor to the general partners and granted to the general partners the authority to sign, execute, certify, acknowledge, file and record any Amendment to the Certificate of Limited Partnership.

The General Partner acknowledges and states that she is authorized to execute and file this Amendment to Certificate for and on behalf of the DeGuzman Family Limited Partnership.

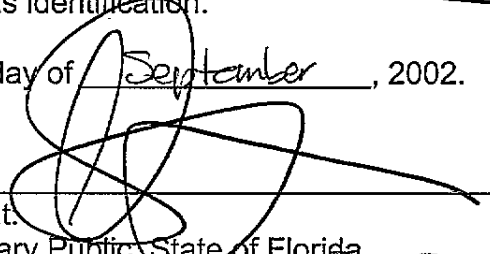
