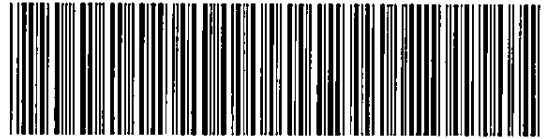

SECOND: The Certificate of Limited Partnership (the "Certificate") was filed with the Secretary of State of the State of Florida on January 23, 1995.


THIRD: Paragraph 5 of the Certificate is hereby amended to read in its entirety as follows:
