SECOND: Upon October 27, 1997, the WCPR Family, Ltd was issued a Certificate of Amendment changing its name to WCPR, Ltd..


THIRD: The reason for filing the Certificate of Cancellation is that the Partnership is no longer conducting affairs in the State of Florida which require the continuation of the Partnership.
