CERTIFICATE OF LIMITED PARTNERSHIP  
of

This Limited Partnership Agreement made this 07<sup>th</sup> day of March, 1995, between Making Moves, Inc. as General Partner (hereinafter "General Partner"), and such other persons or entities who hereafter shall be admitted as Additional or Substituted Limited Partners pursuant to the terms of the Articles of Limited Partnership. The Limited Partners, together with the General Partner, shall collectively be called "Partners".

WITNESSETH:

ARTICLE I -- FORMATION OF LIMITED PARTNERSHIP

The Partners agree to enter into and form this Limited Partnership under the Florida Revised Uniform Limited Partnership Act (1986) (hereinafter "the Act"), which shall govern the rights and liabilities of the Partners except as expressed in the Articles of Limited Partnership.


